# **OFFICERS REPORTS**

# **President's Report – Michel Langlais**

Welcome to the National Sculpture Society's Annual Meeting, which is always our first meeting of the year. As we do every year, I will summarize some of the business and programs that took place in 2019. A complete Annual Report summarizing all committee business in 2019 is available here for you to take, or the offices will be happy to email you a copy upon request.

Our Board of Directors met three times last year: in February, June and October; the Executive Committee held meetings by teleconference between Board meetings, providing continued momentum and attention to ongoing business. Several other standing committees meet throughout the year, as needed.

# The NSS Committees and chairpersons in 2019 were:

- **Communications Committee** Wesley Wofford, Chairman, from North Carolina. Wesley spearheaded three projects last year with the Communications Committee.
  - (1) The first was investigating and purchasing equipment for holding group videoconferences in our offices.
  - (2) The second, and possibly the most monumental project for NSS this year, is the redesign of the NSS website. The committee generated an RFP to send out and we narrowed the field and received bids from 3 different vendors with 3 very different approaches to solving our problems and accomplishing our goals. NSS ultimately hired Van West Media, who we have been working with since last summer. We view this endeavor as a long-term goal that will centralize all our assets into one cloud database. The new website will be more interactive, will provide and gather more information. This is a major project which is scheduled to be completed by spring.
  - (3) The third project of note that the Communications Committee worked on was establishing a Videography Internship to start creating video content for the new website. NSS hired a film student as a Summer Intern, who created several videos of sculpture events and public works of sculpture.

- Editorial Advisory Committee Tuck Langland, Chairman, who is here from Indiana. One year ago, we voted on the agreement to pass the ownership of our magazine to the Policy Studies
  Organization. Four issues of Sculpture Review have been published since then. Recently, the
  president of PSO appointed two NSS Board members, Robin Salmon and Gordon Alt, as co-editors of
  Sculpture Review.
- Education Amy Kann and Tony Antonios, Co-chairs
- Events Donella Lay, Chairman, from Fort Worth, Texas Our three-day Sculpture Celebration Conference was held in New York City in June last year, starting with an intensive modelling competition at the Art Students League of New York on Friday, followed by a party with awards presentations at the Compleat Sculptor in Chelsea on Friday night, events at the Park Central Hotel all day Saturday, ending with the Honors and Award dinner on Saturday night in the hotel's grand ballroom. The weekend was capped off with a Sculpture Safari at the Central Park Zoo on Sunday, attended by thousands of visitors.
- Exhibitions Robin Salmon, Chairman, from South Carolina
   In addition to the 86th Annual Exhibition which was installed at Brookgreen Gardens museum
   August through October, the NSS co-hosted the opening of the 10th Anniversary "Performance in
   Sculpture" exhibition at the Straz Center for the Performing Arts in Tampa, Florida. We also opened
   our own NSS Gallery in midtown Manhattan last year, where we have had three exhibitions to date.
- Honors and Awards Richard Blake, Chairman, from Pennsylvania
- Membership Greg Glasson, Chairman, who lives in New York

Thank you all - chairpersons and committee members - who work on a volunteer basis organizing our programs and helping to shape our future. If anyone here is interested in serving on a committee or has ideas to share – please let us know. We welcome new ideas and your participation.

# Other events of note in 2019 included:

Our continued partnership with Streamline Publications; running a full-page ad in every issue of Fine Art Connoisseur magazine that showcased NSS sculptors and exhibitions. NSS also participated in the **Plein Air Conference Expo (PACE)** April 24-28, which was held in San Francisco and attended by approximately 1,000 artists from around the country. Members of the NSS Northern California Ambassador Community represented NSS at the conference; doing demonstrations, answering questions, and distributing information about the Society.

The NSS Ambassador Program continued to grow in 2019, adding the Carolinas Community, with Dan Kraus acting as Ambassador, to three other NSS Ambassador Communities around the United States:

- 1) Southern California, the "SouthCal Community", where Mark Edward Adams, is the ambassador.
- 2) Northern California, the "NorthCal Community" where Deanna Montero is the ambassador.
- 3) Fort Worth, Texas and Oklahoma, where Donella Lay is the ambassador.

The Ambassador Program was launched in 2016 with the intention of helping NSS better communicate and collaborate with groups of sculptors around the country. It is a time consuming but very rewarding volunteer position; if you are interested in acting as an NSS Ambassador in your community, please let us know.

Our two California Communities just had a great exhibition at Spark Gallery, the most important gallery in San Diego; it was actually their second exhibition and the proof that there is Strength in Union, and what you cannot accomplish alone, is possible to do as a group.

That briefly summarizes our activities and accomplishments over the past year.

We look forward to seeing you at the Sculpture Conference June 5-7 in the Berkshires in Massachusetts this year; the Events Committee has a wonderful series of programs planned at Chesterwood and the historic Seven Hills Inn.

We look forward to working with each of you toward an even better year in 2020. Remember – we need your help! If we work together, anything is possible.

#### Treasurer's Report – Gwen Pier for Hiram Ball (absent)

#### 2019 Summary

The Finance and Audit Committee met five times in 2019. Three of those meetings were quarterly portfolio reviews with our investment advisory team, Wittenberg Holmes Partners, at UBS Financial Services. At the quarterly reviews we examine our asset allocations, review holdings in our portfolio, and are advised of recommended changes in keeping with market fluctuations. Our team at UBS actively manages our portfolio on a continual basis and is responsive to changes in the economy and to our concerns and questions. At least one of the quarterly reviews every year is with the full board and in 2019 the UBS team attended the June Board meeting.

Our investment goal is to grow the principle, participating when things go up and participating less when things go down. The NSS annual draw on investments never touches principal. Since the inception of our portfolio investments at UBS in December 2015 the NSS portfolio had returned 6.76% per year as of 9/30/2019.

The Society's fiscal year coincides with the calendar year. The accounting firm Rogoff & Company performed the independent audit of for 2018 last February/March and will begin the 2019 audit on February 10. A draft financial statement is sent to the Finance Committee for review in March. Once approved, it is finalized and made available to the public.

At our last meeting on December 11, the committee reviewed a draft 2020 budget vs. comparable projections from the prior year. Preliminary numbers for year-end 2019 (which are unaudited and subject to change) indicate that most of the net income and expenses are close to projections. Unusual expenses were those associated with the office move just over a year ago and with the change in publishers for Sculpture Review magazine, and legal fees associated with contract negotiations for both.

In addition to our portfolio of restricted and endowment funds held at UBS, NSS is also the beneficiary of three trusts held at JP Morgan; two were established by our first great benefactor Archer Huntington and the third by our only female past president, Charlotte Dunwiddie. Investment income held a UBS and revenue from the three JP Morgan trusts account for about 58% of our income. Program fees, membership dues, and donations make up the difference and help cover our overall expenses.

I am happy to report that at yesterday's Board meeting, the Board passed a break-even budget with projected expenses and income of \$687,200.

We are optimistic that friends of the organization will continue to participate in growing numbers and support the National Sculpture Society in its mission to promote sculpture. With your help, we look forward to a break-even bottom line in the current fiscal year.

#### **COMMITTEE REPORTS\***

#### **Communications Committee: Wesley Wofford, Chair**

Over the past 12 months we have been working diligently towards some of our goals.

- 1. We installed Zoom Room Hardware for the new offices. We have had multiple meetings via Zoom and have effectively utilized all its features, including screen sharing, recording, etc. We hope to utilize the record and transcribe feature in the future to save valuable staff time writing minutes. We recommend this becomes the common platform for all NSS meetings moving forward.
- 2. We established a Videography Internship to start creating video content. We have generated an Internship Contract that we hope becomes the standard format to formally sign them. Our recommendation is to add a line item to the budget and have 3 interns per year at \$500 per intern and have them in different places around the country. Our targets are young enthusiastic film students or filmmakers who can generate a variety of different types of videos. We had a Southeast intern and a NYC intern. The NYC intern generated videos around the conference, and the Southeast Intern produced 8 different videos on various topics.
- 3. We interviewed 3 different companies to accomplish our goals moving forward regarding social media and website. We generated an RFP to send out and we narrowed the field and received bids from 3 different vendors with 3 very different approaches to solving our problems and accomplishing our goals. As we learned more about this, we realized the most efficient path forward is to build a foundation of software and hardware in the offices, and integrate the staff and all of their separate responsibilities into a streamlined system to reduce redundancy, which then will feed the new website and social media strategies. 2 of the 3 companies worked in this fashion, and after comparing bids, locations, skill sets, and strategies, we recommend that we move forward with Van West Media to accomplish these goals. They have all the skills we need to move forward in an organized fashion, and we feel they will be the perfect partner moving forward. We see this endeavor as a long-term goal and have planned to centralize all our assets into one cloud database, including PSO and the digitization of SculptuREview as well as future grant opportunities being pursued regarding printed office materials.

Van West has been working diligently on the website. We have completed and approved the wireframes and structure of the website and have also been projecting as to how the website consolidates all our various organizational programs. We will need content from the various NSS Committees for the final verbiage, and we hope that they will join our enthusiasm of the project. The website would have more advanced features than the present one to give a more user-friendly experience to visitors.

Updates include but are not limited to:

- We are enabling Category Indexes site wide to help users curate content for themselves based on their interests.
- We are creating a "Find a Foundry' section.
- We are creating a 'Members Only Resource's area that will connect Sculptors with new resources and tools
- We are creating a Vendor/Supplies Advertising Section.
- SculptureNews would be a feature on the site and updated by the office as artists submit news.
- A robust Exhibition area will have links to current exhibitions as well information on past and upcoming exhibitions.
- We will have a Find a Sculptor feature that will enable people to easily locate Artists with various category indexes.
- We have a lot more information than what is here and can share it with anyone who wants to learn more. This will bring the NSS into the 21st century and give us the tools to reach a much larger and younger audience, as well as organize all our assets and preserve them for the future.

 We formed the NSS Digital Strategy Sub-Committee to get feedback from younger members of our organization. They have been providing valuable ideas and feedback about the path forward concerning all our various digital and social media strategies. Members of the sub-committee are Anthony Alemany, Rick Casali, Erik Durant, Justin Kendall, Rina Oh, Brittany Ryan, Robert Stutler, and Dan Willig.

Overall, there have been a lot of exciting accomplishments over the past year, and we plan on the launch of the new website with all the integrated social media platforms in 2020.

The National Sculpture Society held our Annual Meeting and Luncheon on February 2<sup>nd</sup>, 2019, at the Orsay Restaurant in New York City. After our luncheon, Nicholas Opinsky of New York City's Foundation Center, presented a program entitled "Maximize Your Impact". Opinsky is the Foundation Center's Development Assistant and has experience in fundraising, marketing and developing financial growth strategies for clients and art organizations. The presentation was followed by our Annual Meeting. The NSS Sculpture Celebration Conference was held in New York City on June 14<sup>th</sup> – 16<sup>th</sup>, preceded by our board meetings on Thursday, June 13<sup>th</sup> at the NSS offices. The conference started on Friday morning at the Art Students League of New York's facility with a welcome from Michel Langlais, president of the National Sculpture Society. The Richard McDermott Miller Modeling Competition followed in an exhibition room of the Art Students League, during which ten emerging sculptors modeled a portrait from life over a five-hour period while conference participants watched.

That evening a Celebratory Reception and "House-Warming" was held at the Compleat Sculptor's new location. Guests were welcomed by Marc Fields as they explored the store's new location and watched several sculpture product demonstrations. The Miller Modeling Competition's Award winners were also revealed and celebrated.

On Saturday morning, participants gathered at the Park Central Hotel for a short General Meeting followed by Donna Hassler's presentation on Daniel Chester French's retreat, Chesterwood. Hassler is the Executive Director of Chesterwood. Historian Harold Holzer followed with a talk about his new book "Monument Man: The Life & Art of Daniel Chester French". After lunch, Jason Arkles, host of The Sculptor's Funeral podcast spoke on "The Future of Art History: Why Sculpture is Boring (again) and What We Might Do About It".

Participants gathered next at the NSS Gallery in mid-Manhattan to view an exhibition of works from the Society's collection. A reception and the Honors and Awards Dinner were held that night in the Park Central Hotel's Lobby Bar and Ballroom.

Sunday found us at the Central Park Zoo on a "Sculpture Safari". Sculptors modeled animal sculptures from life in various locations around the Zoo. Mark Edward Adams and Carter Jones modeled grizzly bears, Ellen Woodbury created snow leopards, Roger Martin and Paul Rhymer worked on sea lions, and Jason Arkles and Steff Rocknak sculpted in the goats, sheep, cow and zebu area. 1) THE COLLECTION - National Sculpture Society Gallery, NY, NY

The first exhibition in National Sculpture Society's new midtown gallery was "The Collection", an exhibition of sculpture by past and present members of NSS. The show featured rarely seen works by notable sculptors, and ran from Monday, May 20 through Friday, July 26. The 30 pieces displayed included figures, portrait busts and bas-reliefs by historic and contemporary Fellows of NSS.

# 2) CALIFORNIA SCULPTURE: WORKS FROM THE NORTHERN AND SOUTHERN CALIFORNIA COMMUNITIES - National Sculpture Society Gallery, NY, NY

On Monday, August 19th, "California Sculpture: Works from Northern and Southern California Communities" opened at National Sculpture Society's Gallery in New York City. The juried show featured the works of 14 contemporary sculptors and ran through October 18. Jurors were Eugene Daub, FNSS, and Alicia Ponzio, NSS; both elected members of National Sculpture Society residing in California.

The NSS Ambassador Community Program is a relatively new initiative intended to increase communication and individual contact with a growing number of sculptors in regions around the country.
